CORRIGENDUM

Corrigendum-1

Tripura Gramin Bank invited proposal for procurement, installation and maintenance of CCTV surveillance system in Tripura Gramin bank vide Bid Reference No.: TGB/HO/IT/2018-19/01. Following are the changes in the above mentioned RFP

- i) Bank would install colour CCTV surveillance system in 109 no. units subject to increase/decrease as per future requirements.
- ii) Every unit would consist of LED colour monitor for displaying pictures and video record. Please read "LED monitor" instead of "TFT monitor".
- iii) Point no.- 2, sub point (5) If experience of installation of 100 SDVR in any government department/ bank is not available to any intending bidder then the bidder must have installed minimum 500 numbers of cameras in government department / bank.
- iv) Point no. 3, sub point (I), (ii) & Appendix-'D' Selected bidder need to install Dome/ Bullet camera based on the requirement at the site of installation. Cameras quoted do not need to be only "CCD" specific.
- v) Bid should be quoted for cameras & DVR with updated software and hardware. Cameras (Dome/Bullet) should have the following features:
 - a. 2 mega pixel Cameras.
 - b. Should be capable of capturing colour image.
 - c. Should support night vision.
 - d. Should be able to capture clear image up to a minimum range of 15 meters distance in both day and night vision.
- vi) Both Technical and commercial bids should be submitted together in separate sealed envelopes by the same intending bidder. Each envelope should have neatly written on it whether it is TECHNICAL BID or COMMERCIAL BID with the Name and Address of the bidder with Mobile Number.

- vii) Bid abstract: Page no.3, serial no.2 & 3:- Last Date of submission of both Technical & Commercial Bid has been extended up to 7th January 2019 till 16:00 hrs. Date of opening Technical Bid is changed to 8th January 2019 at 11:00 hrs. Date of Opening of Commercial bid shall be notified later. Commercial bid shall be opened only for those bidders who qualify in the Technical bid.
- viii) Bid abstract: Page no.3, serial no.6 & Point no. 10, sub point no. D:- A performance bank guarantee of Rs. 10(ten) lakh instead of Rs 20(twenty) lakh would be required to be given by the selected vendor to the Bank. Bank guarantee would be handed over to the head office within 30 working days from the date of purchase order. 10% of payable amount of bill will be retained by the bank as security deposit and will be released after warranty period. No interest shall be paid on the security deposit/ retention money.
- ix) Point no. 5.3:- Intending bidder shall have to deposit earnest money of Rs. 50000/-(Rupees Fifty Thousand only) instead of Rs. 25000/-(Rupees Twenty Five Thousand only).
- x) Point no. 10: Terms and condition:- Vendor to provide online solution for tracking installation status, lodging complaint for CCTV installed in branches and tracking of complaint status.
- xi) Minimum 90 days continuous backup (including holidays) is required for CCTV surveillance system.
- xii) Appendix-'B', serial number 1:- Product should be registered in GeM (Government e Market Place) portal. Other brand may also be included but OEM must fulfill the eligibility Criteria, technical requirements and specifications.
- xiii) Days will be calculated on the basis of working days. Holidays will not be included in count.

Other terms and condition will remain unchanged.
